Statement by the Attorney -General

Mr President, Distinguished Members of the Working Group, Sovereign States here represented, members of NHRI's and CSO's I wish you a very good afternoon and ask for your indulgence whilst I make this humble statement.

I must, on behalf of the Government and people of Sierra Leone, thank the Working Group of the Human Rights Council for the invitation to fulfil Agenda Item 6 of the Universal Periodic Review during this eighteenth session.

During the review of Sierra Leone in May of this year, 129 recommendations where put forward by states represented at the review. My delegation addressed 101 of those recommendations adequately and promised to submit the outstanding 28 to the stakeholders and the people of Sierra Leone for proper determination of the response. We welcomed the opportunity of being reviewed and most especially, appreciated all recommendations made by State parties.

On our return we presented our report to the President in Cabinet with recommendations for a nationwide consultation to do a presentation to the stakeholders and citizenry alike on the same. This was readily approved and scheduled; with technical assistance from UNIPSIL (which is the field office of the Human Rights Council) these consultations were conducted in August.

The consultations were planned and carried out by my office (Ministry of Justice) and the Human Rights Secretariat in the Ministry of Foreign Affairs and International Cooperation and they covered the major cities in Sierra Leone. The participants were drawn from a wide variety ranging from tribal heads, traders union, prison officers, police, army, general citizenry, CSO's and NGO. The consultations started in the east of Sierra Leone and culminated in the west.

The content of these consultations was a presentation of the report of the review and the recommendations addressed with reasons. The next step was explaining the outstanding recommendations reason for the consultation. At this point an interactive session follows with a view of clarifying any ambiguous points and prepping for the ultimate goal of the consultations. A group session was then commenced where the 28 recommendations were carefully discussed and a determination of the ultimate reaction sought. The object being that after touring the nation a ratio of all reaction to the recommendations will have been determined and the final decision reached.

This approach was very successful as the turn out in all the consultations was higher than anticipated and the feedback carefully tallied for the following outcome:
